6.	Declarations of Final List of Candidates	At 05.00 PM, December 13 <sup>th</sup> , 2019
7.	AGM of DSA	December 29, 2019 at 10 AM (as per communication of DSA dated 27.11.2019)

1. The Electoral Board will conduct the election as per the Delhi Soccer Association, Statutes.
2. Nominations in the prescribed format shall be submitted by the Candidate/Proposer in the office of the Chairman, EB, at Ground Floor, F-13, F Block, Jungpura Extension, New Delhi - 110014, by the last date as noted above in the schedule. After the due date and time no nominations will be accepted.
3. Every nomination for election shall be accompanied by a fee of Rs.3000/-(non-refundable) by way of Demand Draft in the name of 'Delhi Soccer Association' payable at New Delhi. Nomination forms will be available at the office of Delhi Soccer Association, M-12, LGF, Jungpura Extension, New Delhi 110014, during office hours from December 6<sup>th</sup> till last date of filing of nomination as notified in the schedule above.
4. Final list of Candidates will be declared as per above schedule and shall be displayed on the notice board at the DSA office on December 13th, 2019 at 5 PM.
